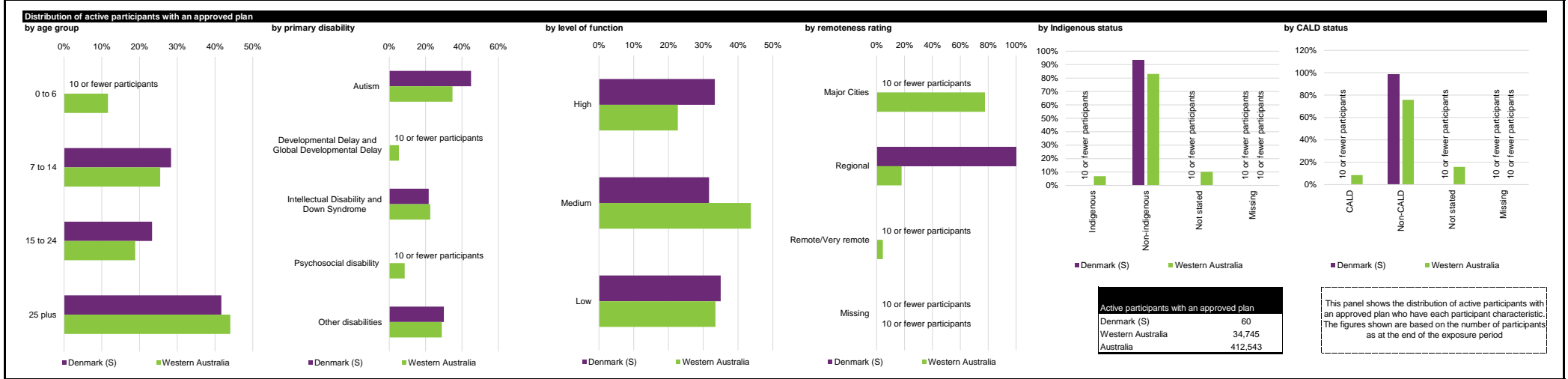
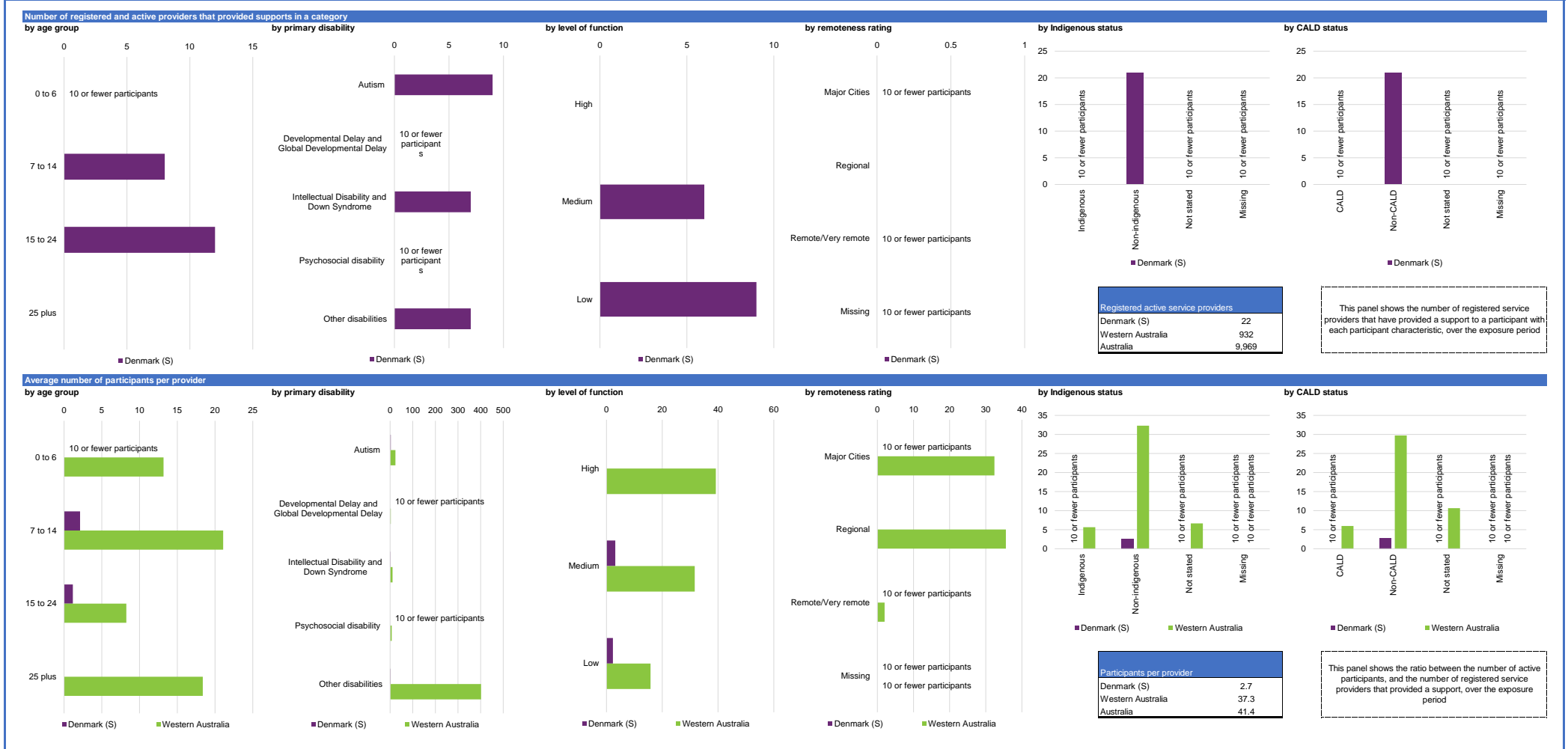


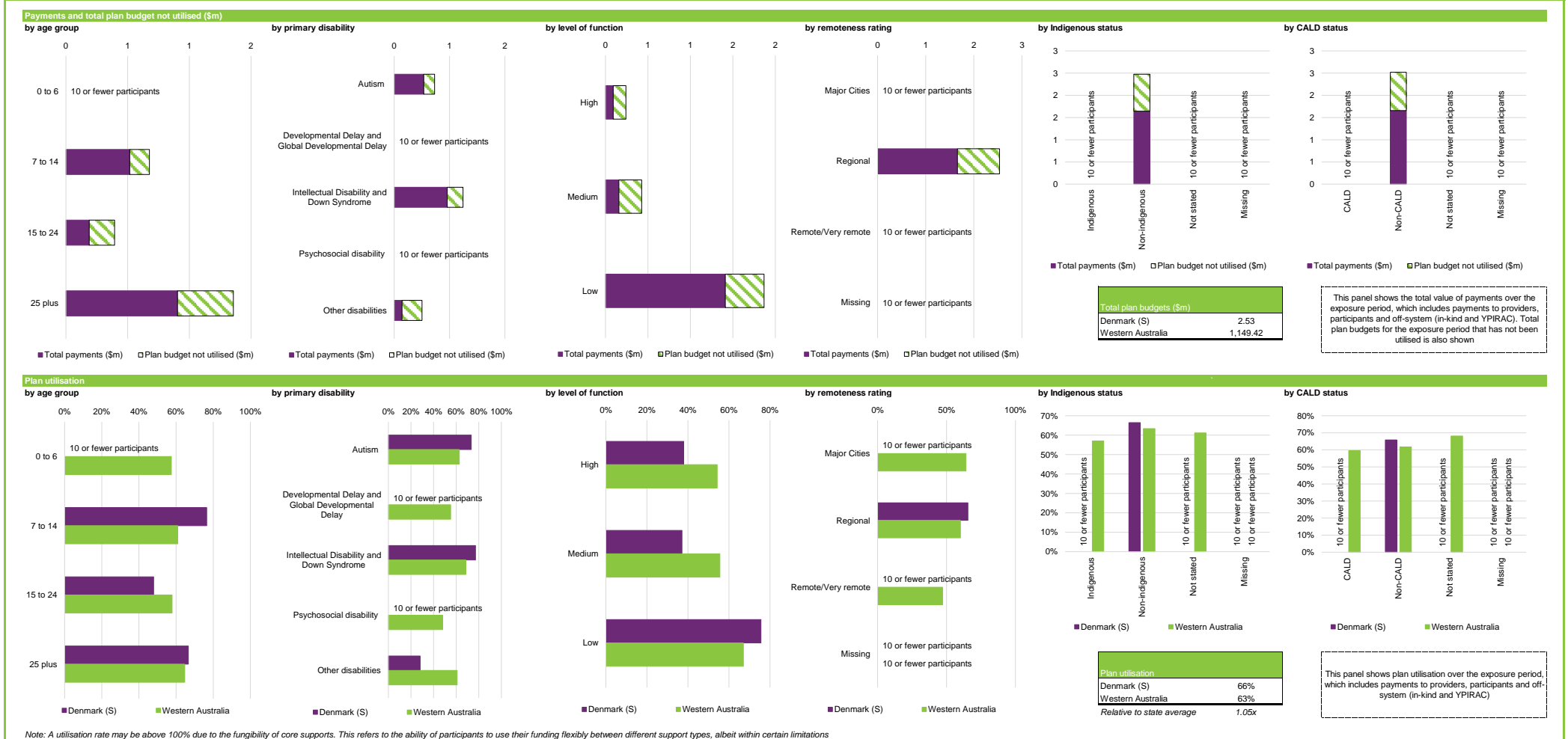

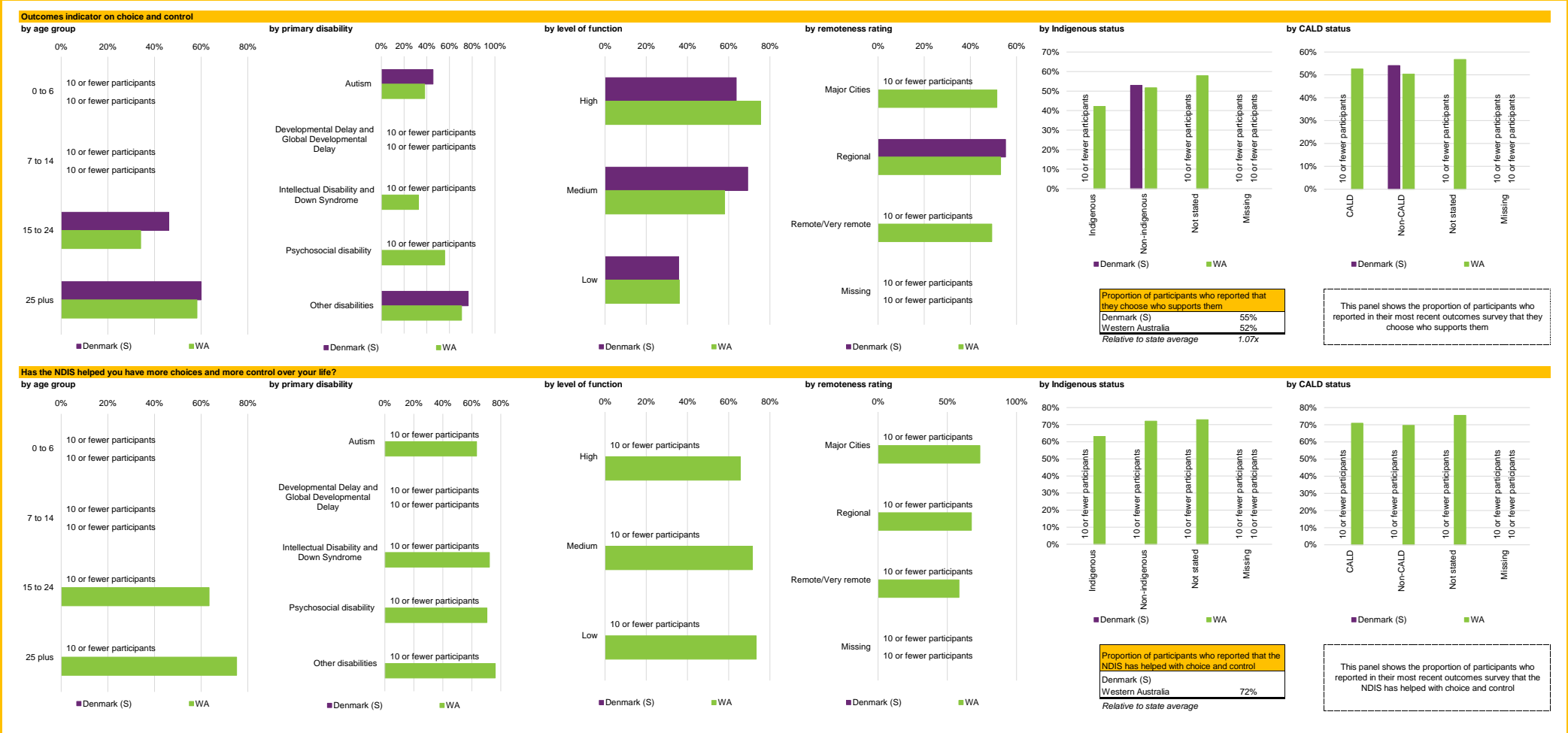

| Total plan budgets                           | Value of supports committed in participant plans for the exposure period  |
